Ingrid Colvard updated the board on a mass vaccination clinic at the Skamania County Fairgrounds that SCSD employees helped to support, and covered current health metrics in Skamania county which remains in the high virus transmission range according to county health officials. Ingrid also gave an update on opening schools for grades PreK-8, which detailed that these grades have returned to inperson learning on 1/19, with 25% of families choosing to remain in remote learning. On the status of high school students, Ingrid noted that the district is still looking at a February opening, but that current health metrics do not yet allow for a specific start date to be established. An update was also given on athletics with the announcement by Ingrid that some practice will be able to begin next week.
