a. School Opening Plan and Update

Ingrid Colvard updated the board on the current health metrics in Skamania county which remains very high in the virus transmission range, and noted that health officials are cautiously optimistic that local cases are trending downward, or at least flattening out. Ingrid discussed opening schools for PreK-8th grade students on 1/19/21 with the option for families to continue with remote-only learning throughout the 2020-2021 school year. Concerning high school, Ingrid updated the board on a possible semester 2 opening in February which is supported by health officials. Ingrid's report also included an update on

staffing considerations that would affect opening the SHS building for high school students.

b. Impact of COVID Learning on Bilingual/English language Learners and Special Education Students

Ingrid provided statements from special education and bilingual educators concerning the impacts on student learning due to COVID
