1. CALL TO ORDER

The meeting was called to order by facilitator Andy Kelly.

2. INTRODUCTIONS

3. REVIEW PREVIOUS MEETING MINUTES/NORMS

The April 10th minutes were looked over. It was discussed that more detail needed to be included. There was a discussion regarding the heating systems and why they've never been upgraded. The cost when compared to the return, didn't justify the expense. There was a discussion regarding our insurance and have we had any audit findings based on the poor conditions of some of the buildings and grounds. Because we are part of the collaborative of ESD #112, our insurance is through them. They have sent teams out to look over our facilities, and the recommendations that they have requested to be done to be in compliance with their insurance has always been met, but it's always been a bare minimum request.

5. ICOS REPORT

Lauren Johnson from LSW Architects presented the ICOS (Information and Condition of Schools) report. The report is a Study and Survey process that OSPI (Office of Superintendent of Public Instruction) requests and is completed per their standards. The report doesn't reflect the education plan (how the district proposes to educate the students of the community) but the district does have one. The state only looks at the ICOS report for their matching fund eligibility. There are two ways to become eligible to receive state funding – unhoused students (the overall square footage of a building vs the number of students attending) and the age of the facilities (30+ years old and having never previously received state funds). The district qualifies because of the age of some of the facilities.
